eHealth's Annual Meeting of Stockholders will be held on June 14, 2011 at the Garden Court Hotel, 520 Cowper Street, Palo Alto, CA 94301, at 8:30 a.m. Pacific Daylight Time.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote **FOR** all the nominees listed and **FOR** Proposals 2 and 3:

1. Election of two Class II directors, Lawrence M. Higby and Randall S. Livingston, to serve for terms of three years and until their respective successors are duly elected and qualified, subject to earlier resignation or removal.
2. Ratification of the appointment of Ernst & Young LLP as the independent registered public accounting firm of eHealth, Inc. for the fiscal year ending December 31, 2011.
3. A non-binding, advisory vote with respect to the compensation of the Named Executive Officers of eHealth, Inc.

The Board of Directors recommends that you vote **EVERY THREE YEARS** for Proposal 4 :

4. A non-binding, advisory vote regarding the frequency of the voting with respect to the compensation of the Named Executive Officers of eHealth, Inc.
